Have I mentioned that fall is my favorite time of the year? On the odd chance that I haven't, I will say definitively that it is so! PUMPKINS IN THE PARK!!


Like to paint or do crafts? The UUMH Pumpkin People exhibit needs you!

DONATE BUTTON

The Donate Button is a Success!

UUMH has been using Vanco to handle online donations since December of 2020. A total of \$20,963 was donated online in FY2022 from 150 transactions. While about 50% of the number of donations were pledges, pledging accounted for 66% of the money that came in. Both Outreach and Plate were 20% of the number of donations and 12% of the money donated. 40 of the 150 transactions were checking withdrawals and 110 were credit card charges.

Our cost for online donations is 2.84% for Visa and Mastercard, 3.75% for AMEX and 1% for direct checking withdrawals plus \$0.45/transaction. There is also a \$10/month service charge. The total effective Vanco fee for FY2022 was \$745 or 3.55% on \$20,963 donated. Of the \$745 in Vanco fees, \$656 was covered by the 3% voluntary surcharge on credit cards and 1% on checks. The effective cost of the Donate Button to the Meeting House was only \$89 last year, making this convenient form of donating a win for the members and UUMH. Thank you for your support.

A MESSAGE FROM THE ENDOWMENT BOARD

As we approach the final quarter of 2022 it is prudent to consider income tax planning with respect to contributions you may be considering. There is a provision in the tax laws that may provide an opportunity to receive a tax benefit from those contributions.

A tax saving measure known as a "Qualified Charitable Distribution" (QCD), may be available to anyone who takes a distribution from an Individual Retirement Account (IRA) during the current year. Normally, any distribution from an IRA is taxable to the recipient as ordinary income. If some or all of that distribution is paid directly to a charity by the IRA custodian, however, that amount will not be deemed income and will not be subject to any tax. In that circumstance the charity (the UUMH, whether in the form of a pledge or contribution to the Endowment Fund), benefits fully from the gift, and the donor (you) will have a reduced tax bill next year.

The Endowment Board cannot properly give anyone tax advice, and individual circumstances may differ, but members of the Board wanted to share this information, and to urge anyone interested in knowing more about this or similar opportunities to consult their tax advisor.

You may make a contribution by writing a check to the UUMH Endowment Fund and sending it to the Meeting House. Any member of the Endowment Board will be happy to answer your questions.

SOCIAL JUSTICE

Actions of Immediate Witness

At the UUA General Assembly each year issues of common values and goals for all UUs are voted on. Here at UUMH we are currently working with UU the Vote doing postcards to get out the vote. We plan to designate a South Eastern MA organization that is helping women denied reproductive rights in their own states to travel to Massachusetts for needed health care. Social Justice will continue to focus on issues of justice at UUMH . By joining with other UUs we can feel connected to common efforts and feel a sense of contribution to the common good.

Outreach Donations for October will be Lower Cape Outreach.

In November, we will join with the Angel Fund collection to support the Chatham Children's Fund.

In December, Social Justice would like to collect hats and gloves to be brought and hung on the Christmas Tree. Also we are thinking of a socks collection (men and women) for a shelter. We could collect in a basket under the tree.

Thanks to Robin Hubbard for UU the Vote and to Bonnie Brydges for her work with Sustainable Practices.

Sustainable Practices

After passing single use Municipal plastic bottle bans in all 15 Cape towns, we will be continuing with the Commercial plastic bottle ban in the remaining 6 towns.

In 2022-23, Sustainable Practices will be promoting and filing petitions targeting carry-out products (containers and utensils) to be available only in compostable ware. We hope to assist in providing new composting facilities at town DPWS.

Our mission is to raise awareness of the impact of all our consumption using plastic. Recycling is NOT the solution; elimination will be.

B&G is responsible for the workings and appearance of the Meeting House. Some things you can see like the painting of the sanctuary woodwork, sanctuary windows, Tracy's office and all the bathrooms. Other things you can't see and only notice when there is a problem.

We arrange to have the building cleaned, the lawn mowed, and the snow shoveled. We help with the transition of the Fleck Room to and from the Thrift Shop. We participate in the health, fire, alarm, and lift inspections and correct any defects.

We are responsible for the technology in the building. We installed LED lights throughout the building except for the cove lights in the sanctuary.

We manage the capital improvement projects like the AV system that supports our hybrid services. We will coordinate and oversee the impeding replacement of our boilers. Sometimes we get good news like the

McClennens financing solar panels on our roof which will be installed this winter which will aid our environment and save us \$3,000/year.
